National Forest Practitioners Gathering in Vancouver, Washington

The Pacific North West Forest Practitioners Forum, organized by the National Network of Forest Practitioner (NNFP) took place May 19-21, 2006 in Vancouver, Washington. This event – the third in a series of 6 regional forums – was a joint meeting between the Non-Timber Forest Products Working Group (NTFP WG) of NNFP and the Plant Conservation Alliance's (PCA) Medical Plant Working Group (MPWG) of the U.S. Fish and Wildlife Service.

The goals of the Forum were to 1) build knowledge about issues concerning the conservation, harvesting, cultivation and use of medicinal plants and other NTFPs, especially in the Pacific Northwest; 2) foster a better understanding of the value of traditional ecological knowledge and its role in public land management; 3) develop more partnership opportunities between Native American tribes and public land management agencies, based on current and past collaboration between these groups; 4) strengthen the capacity of practitioners, native tribes, and agencies to collaborate; and 5) improve access to information and technical assistance.

This was an exciting and innovative meeting. About 50 people attended from diverse areas; participants came from the Yakama Nation, Eastern Band of Cherokee, Appalachian Cherokee Nation, Karuk, Hoopa, Southern Band Tuscarora Indians, NTFPs practitioners and federal agencies including USDA Forest Service and Bureau of Land Management. Discussions included medicinal plants and other NTFPs, invasive species, forest management, commercialization of NTFPs, the use of traditional ecological knowledge and collaboration between federal agencies and Native American tribes.

Four NNFP Board members were also present at the meeting, Jude Wait, President, Amadou Diop, Treasurer, John Squires, Member at Large, and Frank Taylor. Mr. Diop and Mr. Taylor shared their experiences on developing cooperatives in the southeastern U.S., the challenges associated with



cooperatives and the issues facing minority landowners in rural America. In the southeast, NNFP will continue to work with our local partners on non-timber forest products such as ginseng harvesting and the utilization of biomass as an alternative energy source, which are becoming an increasingly important source of income for small farmers and owners of forestland.

Three fact sheets and a white paper will be produced as an outcome of the meeting. The fact sheet topics are: Invasive Species; NTFP Licensing and Fee Systems; Benefits to Native American Tribes and Rural Communities of Prioritizing NTFPs in U.S. Forest Service Management. The white paper will discuss examples of successful collaborations between Native American tribes and the U.S. Forest Service. All four items will be completed and available by August of this year and are free of charge.
